ORDER APPROVING JULY 2016 FEE APPLICATION OF ATTORNEY AD LITEM

Came on to be heard the July 2016 fee application (the “Application”) of Glenn M. Karisch (“Ad Litem”), appointed by this Court as attorney ad litem to defend the interests of the unit holders of TEL Offshore Trust (the “Trust”), who were served by publication and did not answer or appear in this proceeding (collectively referred to as the “Defendants”). The Court finds that the amount noted below is reasonable for fees and expenses of Ad Litem, that Ad Litem should be awarded such amount to be taxed as costs; and that the trustees of the Trust should be ordered to pay such amount from the Trust now, subject to reallocation as may seem equitable and just at the conclusion of this proceeding.

IT IS, THEREFORE, ORDERED that, of the \$9,730.00 in fees and \$105,195.58 in expenses sought by Ad Litem in the Application, Ad Litem is awarded \$ _____ in fees and \$ _____ in expenses, for a total of \$ _____, to be taxed as costs, and that the trustees of the Trust are ordered to pay such amount from the Trust now, subject to reallocation as may seem equitable and just at the conclusion of this proceeding.
