Order Granting Motion For Continuance


Today the Court considered the Motion for Continuance (the "Motion") filed by Glenn M. Karisch ("Ad Litem"), who has been appointed attorney ad litem by this Court to represent the interests of the unit holders of TEL Offshore Trust (the "Trust") who were served by publication and did not answer or appear in this proceeding.

The Court notes that, prior to consideration of this Motion, the Court entered its Severance Order dated January 15, 2016, in which the matters related to the modification of the Trust and sale of Trust assets, as pled for, in part, in the Original Petition for Modification and Termination of Trust ("Petition") filed by The Bank of New York Mellon, N.A. ("BONY"), as corporate trustee, and Gary C. Evans, Jeffery S. Swanson, and Thomas H. Owen, Jr., as individual trustees (collectively, "Trustees"), the Counterclaim for Order to Sell Royalty Interests, which is pled in Ad Litem's Counterclaim for Order to Sell Royalty Interests and for Accounting, and which is adopted and incorporated in the Counterclaim for Order to Sell Royalty Interests and for Accounting filed by RNR Production Land and Cattle ("RNR"), were severed into Cause No. C-1-PB-16-000096 styled "In re: TEL Offshore Trust" (the "Severed Proceeding"). This order relates to those matters which were *not* severed into the Severed Proceeding.

The Court finds that good cause exists to grant the Motion and to continue the trial of this proceeding until an appropriate later date to provide the time needed to process information provided by and to be provided by the Trustees and to conduct additional discovery.

IT IS, THEREFORE, ORDERED that the trial of this proceeding is continued until an appropriate later date to be set by the Court.
