The Petition for Modification and Termination of Trust, was filed in the Probate Court of Travis County, Texas, in Cause No. C-1-PB-14-001245, on July 10, 2014 by The Bank of New York Mellon Trust Company, N.A., as Corporate Trustee, and Gary C. Evans, Jeffrey S. Swanson, and Thomas H. Owen, Jr., as Individual Trustees of the TEL Offshore Trust. The Record Holders and Non-Objecting Beneficial Owners of the TEL Offshore Trust are Defendants in this lawsuit as beneficiaries of the TEL Offshore Trust.

The nature of this matter is to modify the TEL Offshore Trust Agreement to (1) allow for the termination of the Trust by a court order, and (2) allow the Trustees, as necessary to fulfill the purposes of the Trust and, without the approval of the Trust's unitholders, to (a) sell all or any portion of the Trust's interest in the TEL Offshore Partnership (the "Partnership") or any other assets of the Trust, (b) exercise their rights to dissolve the Partnership, or (c) cause the Partnership to sell the remaining overriding royalty interest owned by the Partnership.
